

# CAR PARK REGULATIONS AND GENERAL PARKING CONDITIONS

# CAR PARK REGULATIONS

# Art. 1

The car parking space is only accessible after:

- you have collected the entry coupon or
- scanned the QR code on our Car Park Pass upon entry or
- the number plate pre-associated with your Car Park Pass has been recognised or
- your Telepass device on board has been detected upon entry

which means you accept the Car park regulations and General parking conditions hereunder.

# Art. 2

The entry coupon can be collected at the car park entrance.

## Art.3

The vehicle may only leave the car parking space after paying.

## Art. 4

Payment must be made before the vehicle leaves the car park. This can be done:

- at the car park checkouts automatic or manned inside the Exhibition Centre or
- using your Smartphone or
- automatically using your Telepass device.

You must exit by no later than the end of the day, after which you will have to pay a supplement.

#### Art. 5

It is forbidden to introduce vehicles carrying flammable or in any way hazardous materials or substances.

# Art. 6

Vehicles parked outside the dedicated spaces will be removed at the user's cost and risk.



Art. 7

The car park Owner/Manager is not responsible for safe custody of the vehicle as they only provide access to the parking area and the availability of spaces. The manager is therefore not responsible for any theft, damage, fire, tampering, vandalism, natural disasters and/or actions of any kind and nature occurring and/or committed on the vehicle.

#### **GENERAL PARKING CONDITIONS**

- A. Vehicle parking is the responsibility and duty of the USER, who will be liable for any damage caused to people, vehicles and property in the car park.
- B. Users are advised to leave their vehicle locked with all the windows closed.
- C. The car park Owner/Manager will not be liable for damage or theft to cars or their contents as specified in the Regulations herein and in the GENERAL PARKING CONDITIONS. No safe custody activities by the car park Owner/Manager are provided.
- D. If the no safe custody clause is not accepted, the user is authorised to leave the car park without delay and at no charge.
- E. Overnight parking is not permitted.
- F. If the entry voucher is lost or damaged to such an extent that it is illegible, the user may pay for parking at the car park checkouts using the vehicle number plate.
- G. Requests for an invoice must be made when paying for parking at the manned car park checkouts.
